Valuers in Firm	Fee per month
1 to 5 valuers	\$110 (inclusive of GST) per month <u>per Valuer</u> for 1 to 5 Valuers in the Firm
6 to 10 valuers	As above, plus \$82.50 (inclusive of GST) per month per Valuer for Valuers 6 to 10
Over 10 valuers	As above, plus \$55 (inclusive of GST) per month for each additional Valuer over 10

Cost Free Data Import

For users upgrading from earlier versions we offer a no-cost data import and conversion process, but with some conditions as follows:

1. This import service has no cost to our client provided that your use of the new system proceeds on the agreed fee basis for a continuous period of six months from the date of conversion. Early exit from that continuous usage period will incur a \$300 exit charge which is based on us recovering our average labour cost of data import.
2. We do not guarantee that your data can all be imported. There are some rare circumstances, especially in respect of extremely old versions of the software and versions of its operating environment, where conversion and import proves difficult. If that situation arises with your data we will discuss it with you. A fee to attempt a successful import may then be involved or a decision to exclude certain data may be taken.

Payment Options

We normally accept two main forms of payment:

1. By credit card, where we process a payment at the beginning of each calendar month in respect of the month ahead.
2. By lump sum payment, either by card or on invoice, for a year at a time.

We do not normally accept arrangements whereby clients self-initiate a monthly payment to us by cheque or direct deposit, since it becomes administratively costly to follow-up if clients forget to make payments.
